Performance Analysis Visit 2021/22
September 2022

- Fewer Emergency Repairs, taking less time to complete
- Increase in Non-emergency repairs and time to complete - addressing backlog and labour/material issues cited
- Reduction in "Right First Time" for both LAs and RSLs, reduction in repairs satisfaction
- Fewer properties meeting SHQS for both LAs and RSLs, increases in SHQS fails and abeyances - **new standards**
- EESSH compliance impacted nationally, less so for RSLs
- Gas safety fails significantly reduced - concentrated amongst a small number of organisations

- Increase in turnover of properties but not back to pre-pandemic levels
- Re-let times still high, RSL times reducing faster
- Proportionally more lets to housing list applicants, proportionally fewer lets to homeless applicants
- Increase in evictions and abandonments - LAs more abandonments, RSLs more evictions
- Rent increases across the sector, most pronounced for RSLs
- Continuing increase in rent collected as % of rent due for RSLs, LAs same level as last year
- Current arrears continue to reduce for RSLs, increase for LAs
- **Reduced tenant satisfaction for most measures**
- "Overall satisfaction", "Quality of Home" and "Value for Money" seen the greatest change for those who have carried out surveys since April 2020



12 Percentage tenants who feel landlord is good at keeping them informed about services and decisions

18 Average hours to complete emergency repairs





117.1 Lettable self-contained houses year end




111 Gas safety fails count as a percentage of C17 Total lettable stock

C4 Abandonments & and I22 evictions as a percentage of stock






127 Current arrears percentage of rent due





I27 Percentage gross rent arrears of rent due







I27 Percentage gross rent arrears of rent due
