The Association held another successful AGM on Wednesday 25th September 2019, where members approved the Management Committee election results. Congratulations to all those that were elected.



Questions from the AGM

Q: Are Wellhouse HA doubling the rent at Innerzone?

A: No.

Q: Is Wellhouse HA joining the Wheatley Group within the next 18 months?

A: No.

Comments

Comment: A shareholder said that DRS advised him that there are no expressions of interest in any vacant land, nor site investigations, valuations or Housing Association Grant claims. After the AGM, the shareholder confirmed he was talking about the Balado Road school site.

Response: Wellhouse HA can confirm that the land has been valued by the District Valuer and site investigations have been completed by Scott Bennett Associates – we are very grateful to our colleagues

at the Department of Regeneration Services (DRS) at Glasgow City Council for releasing grant to cover the costs for these, as well as for a report from Scottish Water into flood mitigation options. The land appears on our most recent Strategic Development Funding Plan (submitted in April 2019) and has done for the previous 3 years.

At time of writing our colleagues at DRS Housing Investment, who would release any future funds to Wellhouse and with whom we deal with, have confirmed that they have not received any such enquiry. It may be that the query was misdirected, but we are unable to tell.

We have recently received a quote for the valuation of the land owned by the Archdiocese. We await more detail from the relevant authorities on the flood mitigation measures for north east Glasgow.

Comment: at least one shop has had the rent doubled this year.

Response: Wellhouse has not doubled the rent on the shop unit in question.

Dog fouling in a public place

What is it?

Dog fouling in a public place is when an owner fails to remove their dog's mess.

If your dog fouls in an open space, you must clean it up.

We provide litter and dog waste bins in many parks and public spaces.

You can also put bagged dog waste in your domestic refuse (green) bin.

The 'bag it bin it' campaign is actively promoted throughout the city and signs are mounted to lamp posts and affixed in problem areas.

What is the fixed penalty?

If you do not dispose of this type of waste in the correct way and are caught, you could receive a fixed penalty notice of £80 issued under the Dog Fouling (Scotland) Act 2003.

The penalty increases to £100 if not paid within 28 days.

How do I report it?

You can report dog fouling using our MyGlasgow app. You can download our app from the App store and Google Play

ANNUAL ASSURANCE STATEMENT

From 2019 ongoing, an annual basis between April to October Wellhouse Housing Association is expected to submit an Annual Assurance Statement to the Scottish Housing Regulator and make a copy of this available for our tenants.


The statement is our way of informing the Scottish Housing

Regulator whether we comply with all the relevant regulatory and legislative requirements of a Registered Social Landlord.

There are three potential statements and the following outlines what each means:

Status	What this means
Compliant	The RSL meets the Standards of Governance and Financial Management and regulatory requirements.
Working towards compliance	The RSL does not meet the Standards of Governance and Financial Management and regulatory requirements, and it is working to achieve compliance.
Statutory action	The RSL does not meet the Standards of Governance and Financial Management and regulatory requirements, and the Scottish Housing Regulator is using their statutory powers to address the non-compliance.

(Under Review) means: The Regulator has identified or received information that means they are reviewing the regulatory status of the RSL and they will update the regulatory status as soon as the review is complete.





Wellhouse Housing Association is pleased to announce that in carrying out or own self-assessment on the Annual Assurance Statement that we are Compliant with all the standards and there are no material non compliances.

Like all good organisations though we recognise that although we are Compliant with the requirements there are always improvements that we can make and we have identified some of these as part of an Action Plan. For us this includes specifically more consultation with tenants outside of the committee framework and more formal planning toward human rights compliance by 2021.

Some of our suggestions for improvement and will be considered by the Management Committee as to whether we will introduce these or not and in determining this we will look at whether these make a difference to our service provision to you. TPAS will continue to work with you and Wellhouse Housing Association over the coming year to take as much feedback as possible.

We hope that the enclosed Annual Assurance Statement gives you reassurance that we continually want to deliver the best possible service whilst never standing still and keeping to all the requirements that is expected of an excellent housing provider.

This is something that we carry out internally on an annual basis prior to the requirement to complete an Annual Assurance Statement as we undertake our own self-assessment.

By the end of March 2020 the Scottish Housing Regulator will publish their Regulatory Standard for each Social landlord in Scotland and we will publish details of this on our website.

Statement from the management committee

Wellhouse Housing Association is a proud, independent social landlord. We take our responsibilities seriously. Our job is to provide decent housing at social rents, meet housing need, provide good customer service and invest in tenants' homes. Our only source of income is your rent money. We aim to keep this money within Wellhouse.

The committee has been really worried about some rumours circulating in the community and questions being asked. We feel it is important to deal with some misunderstandings. We will deal with as many as we can in this statement.

- We are not planning to become part of a large housing association, indeed, are at a loss and to how this rumour started.
- 2. Wellhouse Housing Association is not responsible for services provided by Glasgow City council, which you contribute to through your council tax payments and we don't want you to have to pay twice. We are in close discussions with senior staff and councilors on issues such as littering, fly tipping, dog fouling, insect or rodent problems and refuse collections & recycling.
- 3. Wellhouse Housing Association did not remove Connect Community Trust from the Hub the Trust chose to move

- their offices to Newhills Road. We are not and have no desire to alter, cancel, move, reduce or otherwise change services provided by Connect or any other party. We have not doubled the rent on Innerzone Youth Project. We increased the grant funding we give Connect this year and last year, along with the increased grant for the gala day. We must have some conditions on funding, because it is your rent payments that are used. Also, our own rules, such as those requiring compliance with Housing Regulation, audit, lease and insurance needs, add conditions to the grant. Once again, we are at a loss as to how this story started and we are sure our colleagues at Connect will clarify the facts with us. See the extract from our published accounts re: the financial arrangements.
- 4. We have no intention of answering unfounded, inappropriate, personal or upsetting comments or allegations about staff or committee members. Wellhouse Housing Association will vigorously defend our reputation and are in the process of writing to each individual who has used crude, inflammatory or aggressive language toward us. Please note, some of these actions are

- a direct breach of our tenancy agreement (see below)
- 5. Finally, we are heartbroken to report that we had call the police to attend this year's AGM, due to threats made against the organisation, the Hub and our staff and committee. This has never happened before and is very worrying to us. For clarity, the AGM is a business meeting, not a public one.

Wellhouse HA has worked conscientiously and professionally over the last five years to rescue us from the perilous position we were in at that time, due to serious governance and financial concerns - this cost well in excess of half a million pounds to put right. We have spent no money on these issues since the new Director was employed. We have created a strong, well governed organisation with a professional staff team and skilled committee. We have strong audit returns, good performance results, a strong financial position and a very positive relationship with our regulators. We have righted many issues and problems with the association. We are a community-controlled housing association who strives to provide good services and contribute to a harmonious community. We are at a genuine loss as to why this is perceived differently and who is instigating the stories. We can assure our customers of



our continued commitment to good service.

We have included an extract from our March 2019 accounts on the financial relationship with connect and can confirm that we had proposed a grant of £1,000 for community events last year but CCT never claimed this grant and, whilst we increased their main grant to £20,600, they only claimed £20,000. The grant this

year is £21,300 and this remains unclaimed. £1,000 was contributed to the summer gala day. The full accounts will be on the website by the end of November and they are a public document.



26. Connect Community Trust

Connect Community Trust is not deemed a related party of the Association; however, due to the nature of relationship between both entities, it has been deemed reasonable to disclose their activities separately:

During the year Connect Community Trust charged the Association £1,656 (2018: £19,876) for the concierge service, £4,613 (2018: £2,697) for maintenance work, £nil (2018: £455) for events and promotions, £10,747 (2018: £nil) as a settlement figure in relation to termination of the Facilities Management contract. The Association made £nil (2018: £1,000) of donations in the year.

During the year the Association charged the Trust

£4,000 (2018: £4,000) for Innerzone rent, and £9,402 (2018: £9,402) for costs associated with the lease.

The Association gave a grant of £20,000 (2018: £20,000) to Connect Community Trust during the year.

During the year, the Association incurred expenses on behalf of the Trust to include rent, electricity, gas, rates and repairs, buildings insurance and use of the board room at 49 Wellhouse Crescent amounting to £23,000 (2018: £27,960) that were not recharged. At the year end, the Association owed Connect Community Trust £5,000 (2018: £2,016) and Connect Community Trust owed the Association £10,061 (2018: £8,692).

ACCEPTABLE BEHAVIOUR

TENANCY AGREEMENT

3. Respect for Others

- **3.1** You, those living with you, and your visitors, must not harass or act in an antisocial manner to, or pursue a course of antisocial conduct against, any person in the neighbourhood. Such people include residents, visitors, our employees, agents and contractors and those in your house.
- **3.2** 'Antisocial' means causing or likely to cause alarm, distress, nuisance or annoyance to any person or causing damage to anyone's property. Harassment of a person includes causing the person alarm or distress. Conduct includes speech. A course of conduct must involve conduct on at least two occasions.
- **3.6** You will be in breach of this Agreement if you, those living with you or your visitors do anything which is prohibited in this part of the Agreement and this could result in your tenancy being changed to a short Scottish secure tenancy or terminated by us.
- 3.8 We will act fairly to you in all matters connected with your tenancy. We will not unfairly or unlawfully discriminate against you in any way on the grounds of your race, colour, ethnic origin, nationality, gender, sexuality, disability, age, religion or other belief or other status. If you believe we have acted unfairly to you in any way, you may wish to use our complaints procedure. You may also wish to take independent advice."



Income Advice Financial Gains April 2019 to September 2019



Key Points

- The Income Advisor assisted 135 tenants with benefit issues from April 2019 to September 2019.
- Total financial gains to tenants from the period April 2019 to September 2019 is £311,136.92.
- The Income Advisor assisted 23 tenants to claim Housing Benefit totalling £65,362.45.
- The Income Advisor assisted 18 tenants to claim Discretionary Housing payments of £7,015.39.
- The Income Advisor assisted 12 tenants to make claims for Universal Credit totalling £102,156.76.



'How to Report Issues' to Glasgow City Council and Partners.

Overview

Residents can report issues relating to Fly-tipping, Environmental Health Matters, Litter, Dog Fouling and Road and Lighting Faults to Glasgow City Council Neighbourhoods and Sustainability. Report any of these issues by calling the Antisocial Behaviour Helpline on 0800 027 3901 or via Facebook at Glasgow City Council, Twitter @ GlasgowCC or visit our website at www.glasgow.gov.uk

Flytipping can be reported via Public Health who investigate fly-tipping in order to identify those responsible for this unacceptable behaviour.

Fixed Penalty Notices of £200 may be issued for illegally dumping of rubbish, i.e. fly-tipping. Major offenders may also be referred to the Procurator Fiscal.

We are working closely with our partners to deter this activity and would encourage all residents and tenants to report individuals who are responsible for flytipping in the area. Dates, times

and descriptions of individuals, vehicles being used for fly-tipping including the make, model and registration details if possible will assist in the investigation and enforcement against those who are be responsible for this activity.

To request a Bulk Waste Collection you can telephone 0141 287 9700 and place a request or alternatively on our website which can be accessed on www.glasgow.gov. uk. Alternatively you can contact National Re-use who can take items such as beds, sofas, tables, chairs and bikes that are in good condition and could be re-used. If these items haven't been left outside and sofas and armchairs still have the necessary fire labels attached all donations can be made online at http://www.recycleforscotland.com/ donate-re-use-line-now.

You can also take your bulk items to one of our **recycling centres** and your nearest location is at Easter Queenslie Depot, 90 Easter Queenslie Rd, Glasgow G33 4UL. You can also request a Bulk Waste Collection for chargeable and non-chargeable items using our MyGlasgow app. You can download our app from the App Store and Google Play.

Bin Replacement



Warm Home Discount Update 2019 / 2020

This winter you could receive a one off payment of £140 off your electricity bill for winter 2019 to 2020 under the Warm Home Discount Scheme.

If you are receiving benefits or are on a low income you may be eligible to apply.

The money is not paid directly to you, a one-off discount will be applied to your electricity bill or electricity top up meter between September 2019 and March 2020.

You may be able to get the discount on your gas bill instead if your supplier provides you with both gas and electricity. Contact your energy supplier to check eligibility criteria.

Not all energy suppliers take part in the scheme, so please check with your energy supplier.

Our Income Advisor Laura Reilly can help you apply for your Warm home discount payment.



Best Start Payments & foods - Did you know?

- Did you know dependent on your child's age you may be eligible for Best Start Grants? This could be for up to 3 cash payments.
- Did you know you may be eligible even if you are working as long as you are the main carer for the child and receive a qualifying benefit?
- Did you know you can apply for a Best Start Food card when you're pregnant or at any time until your child turns 3 years old?

Did you know you if you qualify for Best Start Foods you receive?

- £17 every 4 weeks during pregnancy
- £34 every 4 weeks from your child being born up until they are 1 years old

 £17 every 4 weeks when they are aged between 1 and 3 years old

Did you know you can use your Best Start Food card to buy the following?

- plain cow's milk
- · first infant formula
- fresh, frozen or tinned fruit or vegetables
- fresh or dried pulses like lentils, beans, peas and barley
- fresh eggs

Brexit News - EU Settlement scheme

If you are an EU, EEA or Swiss citizen you and your family can apply to the EU Settlement Scheme to continue Living in the UK after 30th June 2021. If your application is successful you will be awarded settled or pre-settled status.

The deadline for applying to the scheme is 30th June 2021. It is free to apply to EU Settlement Scheme.

If the UK leaves the EU without a deal

You will need to be living in the UK before it leaves the EU to apply. The deadline for applying will be 31 December 2020

Settled Status

You will usually get settled status if you:

 started living in the UK by 31 December 2020 (or by the date the UK leaves the EU without a deal) lived in the UK for a continuous 5-year period (known as 'continuous residence')

Pre - Settled Status

If you do not have 5 years' continuous residence when you apply, you'll usually get presettled status. You must have started living in the UK by 31 December 2020 (or by the date the UK leaves the EU without a deal).

- enroll in education or continue studying
- access public funds such as benefits and pensions, if you're eligible for them
- travel in and out of the UK

You can then apply to change this to settled status once you have 5 years' continuous residence. You must do this before your pre-settled status expires.

You will be able to:

- work in the UK
- use the NHS

Keep cosy for less this winter - top tips

With winter just around the corner, here are a few top tips from Home Energy Scotland to help keep you cosy for less.

- 1. Set your heating controls to manage the temperature of your home. Remember to use the weekday and weekend settings.
- 2. By regularly bleeding your radiators you will avoid cold spots and get the most out of your heating system.
- 3. Keep your radiators clear and avoid putting furniture against them. Drying your washing

- on the radiator can make your house colder, and can also encourage condensation and mould growth.
- 4. Your room thermostat should be set to the lowest comfortable temperature (typically between 18°C and 21°C) Turning down the room thermostat by one degree can save up to £80 a year.
- 5. A quick shower uses less water and energy than taking a bath. For every minute you shave off your daily shower, you'll save £7 a year on your energy bills.

6. Use heavier curtains during the winter months and make sure you close them when it gets dark to keep the heat in and the cold out.



Scottish young carers to receive new benefit

Teenage carers in Scotland will be the first in the UK to be given financial support thanks to a new Scottish Government grant.

A new benefit will open for applications on Monday 21 October, with the Scottish Government investing £600,000 to support almost 2,000 young carers in 2019/20.

The Young Carer Grant will be available for 16, 17 and 18-year-olds who spend an average of 16 hours caring for someone who receives a disability benefit.

Shirley-Anne Somerville, social security secretary, said: "I am delighted that we are using our new social security powers to recognise the extraordinary contribution these dedicated young people make to the lives of those they care for. This is the first time young carers anywhere in the UK will receive a cash benefit.

"With more responsibilities and less free time, many young carers don't get the same opportunities as their peers and we want this benefit to support them with activities that many of their peers will take for granted.

"We are putting this extra money in their pockets in what could be a pivotal stage in their lives – when they may be finishing school, looking for employment or starting further education or training.

"This new grant will ensure they are



treated with the dignity, fairness and respect they deserve."

Paul Traynor, policy and external affairs manager, Carers Trust Scotland, said: "Carers Trust Scotland welcomes the Scottish Government's innovative Young Carer Grant, which goes some way to recognising the immense contribution of unpaid young carers in Scotland.

"It is vital that young carers are able to live their own life alongside their unpaid caring roles and are provided with appropriate support to give them a better chance to reach their full potential in all aspects of their lives. At this key transitional time for many young carers aged 16–18 years old, this financial support has the potential to make a positive difference to their lives and alleviate some of the financial difficulties

that these young carers may experience."

Young Carer Grant opens for applications on Monday 21 October.

FOI – FREEDOM OF INFORMATION HOW TO ASK US FOR INFORMATION

The Freedom of Information (Scotland) law will give you the right to request information about any aspect of the housing services we deliver as a landlord, and will apply to us from 11 November 2019.

To request information, all you need to do is ask us.

When making your request, please keep the following in mind:

- Your request must be in writing or other permanent format so that we can refer to it in future. We are happy to accept requests by letter, e-mail or in audio format. If you prefer to visit the office to make a request, we will have blank FOI request forms available at reception from 11/11/2019. If you are unable to visit the office or put your request in writing or other permanent format.
- Include your full name and address within the request so that we can respond to you with the information that you have asked us for. If you make your request by e-mail, please provide your email address (you do not need to provide your post address).
- Tell us what information you would like to access. It would be helpful for us if you could describe what you are looking for as clearly and briefly as possible so that we do not misunderstand your request and do not need to contact you for further clarification. This will allow us to respond to you quicker with more meaningful and relevant information. We would be happy to help you clarify what information you are looking for. This includes explaining what types of information we hold that might be relevant to what you want access to.
- If you would like the information provided to you in a particular format e.g. electronic or paper format, please let us know in your request. If we think the format you have requested is reasonable, we will provide it in that format.
 If not, we will contact you to try and find an alternative way of providing the information to

There may be occasions when we will not release all or some of the information you have requested if we consider that an exemption applies, but if so, we will let you know the reason.

Please note that if you request a copy of your own personal data we hold about you, we will deal with this under the Data Protection Act rather than Freedom of Information.
